



3. Aims and Objects of the society:



RULES AND REGULATIONS OF "SECURE (S.S.)-1994"

1. Name of the Society :  
SECURE
2. Location of the Registered office of the society :  
~~XXXX~~ SAINKULA - 757102. ~~XXX~~  
Mayurbhanj, Orissa, India.
3. Society Established :
4. The society will be known as :  
SECURE.
5. The area of operation : *within the jurisdiction of Mayurbhanj district.*  
India and in particular, the backward districts of Orissa, state, including Mayurbhanj.
6. Interpretations.  
(i) These rules and regulations ~~xxx~~ may be called " Rules and Regulations " of the SECURE ( hereinafter called the rules )

" Governing Body " means the Executive Body as set out in the memorandum of Association and there after the Governing Body as constituted under these Rules.

" Secretary " means the person named as secretary in the memorandum of Association or any person appointed to perform the duties of secretary.

" In writing " in cludes printing, lithography and type writing.

" Year " means the period connecting from 1st. January and ending with the 31st. of December of the same calendar year.

2. " Month means Calendar Months."

7. Aims and objects of the society:  
The objects of the society are generally to promote through out <sup>district</sup> India all respects of Rural Development and in particular, to adopt an intigrated approach to help the rural back ward and poor communities in mobilizing for self-sustaining development organisation

and to build up an institutional base for training of tribal youths as well as young educated professionals.

And in furtherance to the above objects—

- a. To establish and maintain SECURE and branches thereof for the said purpose at such places as may be decided by the Governing Body of SECURE from time to time.
- b. To attempt a process of total human development and social changes in tribal areas through the formation of local level organisations.
- c. To bring awareness among a <sup>target</sup> ~~target~~ group of scheduled tribes and other unprivileged groups such as scheduled castes, small and marginal farmers, the landless and bonded labourers for self-reliance and social Justice.
- d. To better the economic conditions of the target groups, suitable utilisation of existing skills and resources.
- e. To educate and organise the Target Group against exploitation and oppressions for the support of human right.
- f. To emphasize on relevant actions for development of women and children belonging to the unprivileged group.
- g. To establish a training base for the grass root functionaries drawn from the Target Group as well as the young educated professionals. The training would cover an education, agriculture, health, rural appropriate technology, skill improvement, and income generating activities.
- h. To expand developmental awareness and activities by playing a supportive role to the existing youth organisation by forming new ones in the neighbouring areas.
- i. To become self-supporting in areas of agriculture, animal husbandry and processing on no profit and no loss basis.
- j. To undertake research studies relevant to the target group with the aims of searching alternative development strategies.
- k. To disseminate informations regarding the aims, objects, and activities of SECURE to edit, print, publish and exhibit books and pamphlets and maintain libraries and documentation centres and to organise seminars and workshops, camps and games bearing upon the aim and objects of

1. To develop areas of mutual co-operation, and understanding among different voluntary organisation and other Government or non-government agencies working for similar cause in India or else-where.
- m. To acquire and dispose of property in furtherance of the objects of SECURE.
- n. To do all other lawful things as may be incidental to or conductive to the attainment of the above objects.

8. MEMBERS :

For the purpose of registration the members of SECURE is declared to be seven but may at any time increase the number.

There shall be following classes of members of SECURE.


- a ) Founder Member.
- ( b ) Ordinary Member.
- ( c ) Life Member.

- 9.(a) Founder members shall be the signatories of memorandum of Association.
- (b) Ordinary members shall be such persons as are admitted to SECURE as ordinary members.
- (c) Life members shall be such persons as may be admitted to SECURE as life members in accordance with the rules.

10. Founder members and life members shall be entitled to vote at the General Meetings.

(a) The rules relating to admission of members and their removal shall be such as may be prescribed by the Governing Body from time to time.

(b) A resignation of membership shall be tendered to the secretary and shall not take effect until it has been accepted on behalf of SECURE by the president.

11. Every ordinary, Institutional or life member shall pay, prior to admission such membership fee as may be determined by the Governing Body from time to time.

12. Ceaseure of Membership :

Any member may be removed from SECURE by resolution of the Governing body passed by the majority of at least three fourth of members present and voting at the special meeting of the Governing Body of which no less than twenty one day previous notice shall be given to the member whose removal is in question and to all the members of Governing Body. ~~Such~~ Such notice shall include a copy of the proposed resolution for removal of the member.

13. ~~XXXXXXXXXX~~

SECURE shall function notwithstanding that any person who is entitled to be a member by reasons of his office is not a member of SECURE for the time being and notwithstanding any other vacancy in its body whether by non-appointment of otherwise and no act or proceeding of SECURE shall be invalidated merely by reason of the happening of any of the above or of any defect in the appointment of its members.


AUTHRTIES :

14. The following shall be authorities of SECURE

- (a) President.
- (b) Vice- President
- (c) Secretary
- (d) Such other persons who may be declared to be authorities of SECURE by the Governing Body.

15. President and Vice - President :


A president and vice -president may be elected at a Gernral Body meeting of SECURE by a majority of votes and they shall ~~exercise~~ exercise such powers as may ve conferred upon them from time to ~~xxx~~ time by the Governing Body, They shall hold office for two years from the date of election.

Governing Body:

16. The Governing Body shall consists of:
  - (a) The President
  - (b) The Vice- President
  - (c) The Secretary
  - (d) Two members elected at the Annual ~~Gen~~ General Body meeting of SECURE by a majority of votes of the members present.
17. There shall be the governing body of not more than 9 members and ~~xx~~ not less than 7 members including the president.
18. All the members of Governing Body except the secretary shall normally hold office for a period of two years from the date of election.
19. Casual vacancies of the office of president, Vice-President or a member may be filled up by cooption of any members or members of SECURE by the remaining members by the Governing Body and ~~or~~ a person or persons appointed in the vacancy shall hold office of the unexpired period of the tennure.
20. The Governing Body shall function not withstandig that any person who is entitled to be a member by reason of his office is not member for the time being and not withstanding any other vacancy in ~~xxx~~ its body wheather by non- appointment or otherwise and not act or proceeding of the Governing Body shall be invalidated nearly by ~~xxx~~ reason of the happening of <sup>n</sup> any of the above events of any defects in the appointment of its members.
21. Any elected members who fails to attend <sup>See</sup> ~~three~~ consecutive meetings of the Governing Body without Proper leave <sup>from</sup> of the presedant ~~shall~~ <sup>be</sup> cease to be a members there of.



22. Any vacancy in the membership of the Governing Body shall be filled by the Governing Body from among the members of SECURE.

Proceedings of the Governing Body :

23. Every meeting of the Governing Body shall be presided by the president and in his absence by the vice-president. In the absence of either, by a person chosen by the members present from among themselves.

24. Two members of the Governing Body present in person shall constitute a quorum at any meeting of the Governing Body.

25. No less than fifteen clear days notice of any meeting of the Governing Body shall be given to each member on his address in the rolls of members.



26. At least one meeting of the Governing body shall be held every year.

27. For the purposes of the last rule, each year shall be deemed to commence on 1st January and terminate on 31st December of the same calendar year.

28. The President may himself call or cause the secretary to call a meeting of the governing body at any time

29. Each member of the Governing Body including the president shall have one vote and if there shall be equality of votes on any question, the president or the chairman shall have casting vote. Where there is a difference of opinion among the members of the governing body, the opinion of the majority shall prevail.

30. Any business except such as the Governing Body may by general special order be directed to be placed before the meeting may be carried and by circulation among all its members by a majority of the members signing shall be effectual and binding as if such resolution had been passed at a meeting of the Governing Body have recorded their views on one of the resolution.



Functions and Powers of the Governing Body :

- 31. It shall be the functions of the Governing Body Generally to carry out the objects of the Association as set forth in the memorandum of Association of SECURE.
- 32. The Governing Body shall have the management of all the affairs and funds of SECURE and shall have the authority to exercise all powers of SECURE.
- 33. Subject <sup>to</sup> the rules and regulations, the Governing Body shall administer and manage all the affairs of SECURE.
- 34. The Governing Body shall have control in regard to all matter relating to the management and organization of SECURE. In addition to the powers and authorities by those present or otherwise expressly conferred upon them they may exercise all such powers and do all such acts and things as may be exercised or done by SECURE and are not hereby or by status expressly directed or required to be exercised or done by SECURE in a General Meeting.
- 35. Without Prejudice to the General Powers conferred by the last preceding clause and other powers conferred by those present, it is hereby expressly declared that the Governing Body shall have the following Powers, this is to say:
  - (a) To pay all expenses incurred in carrying out the objects of SECURE and to make and give receipts, releases and other discharges on behalf of SECURE.
  - (b) To ~~be~~ make every, amend or repeal rules and regulations of the Association and to approve by-laws proposed by the secretary for the working of SECURE.
  - (c) To acquire for SECURE any property, rights and privileges on such items and conditions as they deem fit.
  - (d) To invest and deal with any money of SECURE not immediately required for the purpose <sup>here</sup> of in such manner as they deem ~~fit~~ and from time to time <sup>to</sup> ~~invest~~ acquire or realize such investments.

(e) To enter into and secure fulfillment of any contracts or engagements on behalf of SECURE ~~and~~ <sup>and to</sup> institute, defend, compound or abandon any legal proceedings by or against or otherwise concerning the affairs of SECURE and to refer any matters, claims or demands to arbitration and abserve and perform awards.

(f) To set up, constitute and organise ~~local~~ branches of SECURE in such a manner and on such terms as may be considered <sup>desirable</sup> ~~necessary~~ necessarily members of SECURE and vary the same and delegates to them such powers as may be considered necessary for the <sup>of</sup> purpose.

(g) To appoint a secretary, instructors, scientists, Technologists, skilled workers, professionals, technical advisors, and other to carry ~~out~~ the objects of SECURE and to pay them such remunerations as may be considered expedient.

(h) To accept ~~or~~ money from the Government and donation from other public bodies, corporations, companies or persons for the purpose of SECURE on such conditions as may be agreed to.

(i) To provide funds for all or any of the objects of SECURE in such manner as may be considered expedient.

(j) To borrow or raise any Money that may be required by SECURE upon such terms as may be deemed advisable and in particular by the issue of bonds, debentures, bills of exchange, promissory notes or other obligations or securities of SECURE or by mortgage or charge of all or any part of ~~any part~~ of the property of SECURE.

(k) To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange and other negotiable or transformable instruments.

(l) To purchase, take on lease or in exchange, hire or otherwise acquire any movable and immovable property and in particular any land, buildings, workshops, factories, laboratories, machineries, plants, apparatus, appliances and any right or privileges necessary or convenient for the purpose of SECURE and to construct, correct, alter, improve and maintain any ~~building~~ building and to manage, develop, sell, demise, let mortgage,

dispose of turn to account, or otherwise deal with all or part of the same and also to sell any property of SECURE for cash or any other consideration to promote the objects of ~~SECURE~~ SECURE.

(m) To pay all expenses, preliminary or incidental to the formation of SECURE and its registration.

(n) To establish support or aid in the establishment and support of institutions, funds and trust calculated to benefit employees or ex-employees of SECURE of the dependants or connections of such ~~persons~~ persons and to grant superannuation benefits and allowances to and to make payments towards the insurance of such persons.

Powers and duties of office bearers :

36. President :

(a) The president shall preside at all meeting of General Body and the Governing Body of the Society.

(b) The president only at the event of the equality of votes shall exercise vote.

(c) The president shall perform and carry out and exercise all powers duties and functions as the Governing Body may assign to him

37. Vice - President.

(a) In case of the president's absence Vice-president shall preside at all meeting of the General Body ~~body~~ and the Governing Body of the society.

(b) The vice-president shall perform and carry out and exercise all powers, duties and functions of the president in his absence.

38. Secretary :

(a) The secretary of SECURE shall be the principal executive officer of SECURE and shall exercise all powers of the Governing Body. He shall report all action taken to the Governing Body at its next ~~next~~ meeting.

(b) He shall sue or be sued on behalf of the society in all

Recording of Proceedings :

39. The secretary shall cause minutes of all proceedings to be duly entered in books provided for the Governing ~~xxxx~~

~~Body~~

(a) Of the name of the members of the Governing Body and of any committees of the governing Body.

(b) Of all orders made by the Governing Body and ~~xxxx~~ committees of the Governing Body.

(c) Of the all resolutions and proceedings of the General Meeting and meetings of the Governing Body and committees .

General Body Meeting :

40. (a) General Body Meeting shall be held once a year at such time (not more than fifteen months after the last proceeding meeting) and place as may be prescribed by SECURE in the General Body meeting and if not other time or place as may be determined by the Governing Body.

(b) Fifteen clear days notice shall be given of every ordinary General Body meeting to every member containing the agenda for the meeting in the manner herein-after prescribed. Any urgent extra-ordinary meeting convened to consider any urgent ~~xxxxxxx~~ business or in case of an emergency to which the Governing Body shall be the sole Judge shall be convened by giving ten clear days notice containing the agenda for meeting every member in the manner here in after prescribed. Subject to the same any extra-ordinary General Body meeting shall be convened by giving no less than fourteen clear days notice containing the agenda for the meeting in the manner here-in-after prescribed.

41. The General Body meeting referred to in the last proceeding clause shall be called ordinary meeting. All other Meetings ~~of~~ of SECURE shall be called extra ordinary meetings.

42. Notice of meeting shall be given to all members on the ~~ix~~ role of SECURE and sent by registered post together with proposals or resolutions to be laid before the meeting but an accidental commission or non-delivery or such other cause shall not invalidate the proceedings of the meeting.-

43. The business of an ordinary meeting shall be

(a) To receive and consider ~~the~~ the accounts the balance sheet and the report of the Governing Body and the auditors.



(b) To elect the president, vice-president, and all members of the governing body except the secretary who shall be appointed by the Governing Body.

(c) ~~The~~ transact any other business which under those present ought to be transacted at the ordinary meeting.

44. All other business transacted at an ordinary meeting and at all business transacted at an Extra ordinary meeting shall be deemed special. If any member has any proposal or any matter which he wishes to make or bring before an ordinary meeting he shall give fourteen days notice thereof to the ~~Secretary~~ Secretary.


45. The President or in his absence the vice-president shall preside at the meeting of SECURE and in the absence of the president or the vice-president at such meeting the member shall choose any members of the Governing Body or in the absence of the members of the Governing Body any member present at the meeting to preside as chairman at the meeting.

46. One fifth of the member of the SECURE present in person shall be sufficient to form a quorum of any General Body meeting.

47. No member shall be entitled to ~~vote~~ vote if his subscription is in arrears for over a period of three months.

48. At any General Body meeting a declaration by the chairman that a resolution has been carried or carried by particular majority or less or not carried by a particular majority an entry to that effect in the ~~book~~ back of proceeding of SECURE shall be conclusive evidence of the fact without proof of the number and proportion of the votes recorded in favour of or against such resolution.

49. The Chairman of the General Body meeting may with the consent of the meeting adjourn the same from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place.



Accounts :

50. (a) The SECURE shall maintain proper accounts and other relevant records and papers, ~~an~~ annual statement of accounts in such form as may be prescribed from a chartered Accountant.

*Accountants* (b) The Account of SECURE shall be audited annually by a Chartered ~~an~~ in connexion with the audit of accounts ~~of~~ shall be palble by SECURE.

(c) ~~the~~ True accounts shall be kept of the sum received and spend by SECURE. The accounts of SECURE shall be examined atleast once in a year and the correctness of the balance sheet certified by a qualified auditor. *two sets*

Audit : Inspection.


51. The Accounts of the society shall be audited by any qualified chartered accountant and/or by any Government Auditors. *Any authorised Govt. officer can inspect the records of the Society.*

Annual Report :-

52. A draft of the Annual Report and the yearly accounts of SECURE shall be prepared by the Governing Body and placed before SECURE of its annual General Body meeting for consideration and approval.

53. The income and property of SECURE where-so-ever derived shall be applied solely towards the promotion of the objects of SECURE and no portion there of shall be paid or transferred directly, by the profit, to the members of SECURE providing that nothing there inshall prevent the payment in good faith of resonable and proper remuneration to any officer or servant of SECURE or to any member of SECURE in return for ~~service~~ service rendered to SECURE or for any material. Labour, Plant or Power supplied for ex-perimental purpose, not prevent the payment of interest at the rate not exceeding six percent per annum on money lent or payment of resonable and proper rent for premises demised or let by any members of SECURE whether a member of the Governing body or not from exercising processes and making, using, acquiring and landing any article and things in the course of his business for profit or otherwise under any license or permission in respect of any discovery, ~~discovery~~ invention and patents


